**Notice of the Status of Buyback of Company Shares**

(Buyback of Company Shares Based on the Articles of  
Incorporation as Stipulated in Paragraph 2, Article 165, of the Companies Act)

At the Board of Directors meeting held on January 28, 2015, FUJIFILM Holdings Corporation (the “Company”) resolved to buy back the Company’s shares, based on the stipulations of paragraph 3, Article 165, of Japan’s Companies Act, as interpreted in the light of Article 156 of the Companies Act.
